- To demo we require a credit card imprint plus appropriate I.D. from one member of the party.
- An additional fee of \$25 will be charged for bicycles returned excessively dirty.
- An additional fee of \$25 will be charged for bicycles returned to a location other than where they were obtained.
- The customer understands and agrees that the equipment described in this contract remains the property of The Bicycle Chain and that failure to return said equipment within the time provided may constitute a crime that can be prosecuted.
- The customer acknowledges that he/she has examined the condition of said equipment and agrees that he/she will return the equipment in the same condition as when received, ordinary wear and tear excepted. If not, the customer is expected to repair or replace lost, stolen, damaged, or broken parts or to reimburse The Bicycle Chain therefore. Regardless of the party at fault, the customer understands and agrees to be responsible for damage or loss of said equipment.
- The customer understands and agrees that any subleasing or renting of demo equipment is prohibited and that any such actions shall immediately cause termination and cancellation of this contract.
- The customer understands and agrees that The Bicycle Chain has the right to terminate this agreement at any time, and for said purpose The Bicycle Chain may enter upon the premises of the customer without becoming liable for trespass.
- The customer understands and agrees to assume liability for any and all damage or loss to personal property, person, and injury to other person related to said equipment.
- The customer understands and agrees to return said equipment during regular business hours, inclusive of the day noted on this contract, and to pay for additional days use if said equipment is returned later than the prescribed date or time, regardless of party at fault of whether the equipment was used on the succeeding days.
- Any deposits given by the customer shall be applied to and guarantee the faithful performance of all provisions of this agreement, and for all sums which now or hereafter be due hereunder, and for all repairs necessary to such equipment. If any action is brought to enforce any of the terms of this agreement, or to recover any sum due hereunder, the customer agrees to pay all attorney fees, court costs, and other expenses.
- You may apply up to \$100 worth of demo fees towards the purchase of a similar bicycle, light, or saddle.
